### AGENDA ITEM 2020      HS2 – FURTHER CONSULTATION

#### 1. Background

1.1 HS2 have issued the following notification:

#### ***HS2 Phase 2b – Western Leg Design Refinement Consultation and update OCTOBER 2020***

*Following the Oakervee Review at the end of 2019, the Government has decided to proceed with legislation for the Western Leg of Phase 2b as a priority. The final design and phasing of both the Western and Eastern Legs of Phase 2b will be confirmed as part of an Integrated Rail Plan, which is due to be published by the Government later this year.*

*Subject to the conclusions of the Integrated Rail Plan, a hybrid Bill for the Western Leg is being prepared for deposit to Parliament early in 2022 or sooner, if possible.*

*This update includes information about:*

- a consultation on four proposed changes to the current design of the Western Leg of Phase 2b;*
- an update on last year's Design Refinement Consultation;*
- details of a route-wide update for the Western Leg; and*
- an update on safeguarding.*

#### ***Western Leg Design Refinement Consultation***

*On 7 October 2020, the Minister of State for Transport announced a consultation on four proposed changes to the design of Phase 2b.*

*These proposed changes are based on design development, ongoing engagement, and future integration with Northern Powerhouse Rail and other transport projects. The proposed changes only affect the Western Leg of Phase 2b.*

*The consultation closes at 11:45pm on 11 December 2020.*

*The proposed changes for consultation are:*

- the addition of Crewe Northern Connection and changes to the design of Crewe North Rolling Stock Depot;*
- changes to the design of Manchester Airport High Speed station;*
- changes to the design around Manchester Piccadilly High Speed station; and*
- the introduction of a new train stabling facility at Annandale, in Dumfries and Galloway.*

#### ***Updates to Western Leg proposals and safeguarding***

*As well as the changes being consulted on, there have been a number of smaller changes to the design of the Western Leg of Phase 2b. These are a result of ongoing design development and feedback received during previous consultations and engagement with stakeholders and communities.*

*Also included in the update are plans for proposed works to Preston and Carlisle stations. High speed trains will continue from the new railway along the West Coast Main Line to provide services to the North, North West and Scotland.*

*We are contacting people whose property or land is directly affected by our proposals to arrange online or telephone appointments.*

## **2. Report**

**2.1** This communication presents a complicated set of documents and consultations. However, in summary, the position is as follows:

- The new consultations relate to matters outside the parish boundary and do not directly affect Pickmere Parish – thus for instance the proposed spurs at High Legh included to accommodate links to any new Liverpool-Manchester railway link (Northern Powerhouse Rail).
- Also published at this time are proposals for detailed elements of the Crewe-Manchester part of HS2b that have been amended as a result of the previous large consultation exercise in which your Council made significant comments – about for instance the proposed closure of Budworth Road and the extensive engineering works proposed to secure the crossing of Pickmere Lane and the railway. These changes can be viewed on-line via one of the links noted above, but the detail is difficult to distinguish on a computer screen. A plan booklet showing these changes should have been supplied by the time of your Council meeting. In any case, however, these amendments are not subject to the

current consultation process – they are publicised simply as HS2’s response to comments that were made in previous consultation exercises. These amended proposals will go forward into the Hybrid Bill, which HS2 aims to publish in early 2022, and any further comments on the proposals will have to await that process.
