High Speed Two (HS2) is the new high speed railway for Britain.

As part of preparations for HS2, we are investigating ground conditions along the Phase 2b route. The detailed information we get from ground investigations will help us to design and build the railway in the safest and most efficient way.

The works are being managed by our contractor Balfour Beatty.

Investigation work is due to begin at sites along the proposed route in Pickmere and Tabley on:

Balfour Beatty has reached agreement with the landowners and tenants to carry out the work.
