She will now submit figures for excessive water loss at time of burst, and use of electricity during repair time, to the Loss Adjusters and hopefully we will be reimbursed for those. Joan Webb thanked the clerk for her involvement in the administration of seeing the repairs through, and AS's help in attending the Hall ensuring right decisions were made. Thanks also to SW and AS for their assistance in putting the Hall back to normal, and to Alan Fogerty for helping Clerk with meter readings and assessments.

5. PARISH PLAN UPDATE

The launch of the Plan will take place at the Village Hall on the evening of Saturday April 17th. There will be wine, cake and nibbles. Bron Kerrigan, Parish Plans Development Officer, will be in attendance and will give a speech. A Marquee will be set up on the Car Park to give more space. The most important themes identified were sport and Leisure. Councillor RP stated the importance of carrying the Plan forward now and therefore more volunteers needed.

She will be doing another session later this month. In order to try to attract more people at her surgeries she is varying the times of these. Report from Cheshire East re Local Service Delivery for Town and Parish Councils. Clerk to reply "interested" – so that we are kept up to date on actions that are being taken.

Manchester Airport have sent detailed reports on work to take place in the near future and this will involve nightime runway closures. There may be some disruptions due to this flight pattern changes.

Register of Interest: - Council will be sent forms to complete so that Register is up to date.

Insurance administration will now be done by AON but policy with Allianz. Councillor DH will check new documents with old. Due payment early June.

9. IROS

Benches now been removed (temporarily) by a Councillor, for safe storage, as incidences on them being used for other purposes.

Hedging been laid (£520) around IROS. SW removed all rubbish. Trees now need pushing up and supporting, and DH will assist SW in this.

Repairs and dry cleaning now complete following damage following by burst pipes, in very cold spell of early January.
