In Nicky White's absence the Clerk distributed the report on analysis details of 2006/07. Various items were discussed i.e. Calendar Sales. The clerk reported that the balance for the General Current Account stands at £1,813.83 and Lakeside Current at £799.07 at the end of May statement received on 4th June. ? to move some from General Current; discuss in August meeting when all cheques from this month have gone out.

RF reported on the phone call from Cathy Swindells (Landscape Officer MBC) re adoption of open spaces land on Clover Drive. Discussion took place re the problem that Persimmon (who took over from Westbury Homes) are not completing the work needed and that MBC will not adopt it in its present state, eg railings need repair etc. VB to do letter to Macc and RF to send. Ask just what needs to be done in order for them to take it over; identify standards.

7. IROS

VB discussed maintenance work that needs to be done around rose garden (Christmas Tree plot!) the sundial area and frontage of IROS, as part of the grant given for these areas to be created. Need someone to control/care for it. JW will ask Philip Clark if he will do this.

RF reported message from Joe Robinson that residents in first house in Jacob's Way were complaining about youths being able to climb onto black control box by black gates on pathway, and then they could climb wall into their garden. In the past these residents have had a theft. Can the black box be removed. Discussion. JW will look into. RF report back to Joe Robinson.

The geyser in the pavilion has been leaking. Too expensive to repair. JW will contact electrician.

8. VILLAGE HALL

RF had tried to get an update on Reels on Wheels from Sheila Malley but had not heard from her.

Mr Massey to do partition etc around new gent's toilet.

9. SUB-COMMITTEE

10.WEBSITE

RF reported on email received recently from Dave Harris. (Absent due to holiday). He is still working on website and hopefully will have it ready for August meeting.

11. PARISH PLAN

RP is still working on involving a member from any group known in Pickmere, to form a basis for first stages of development of Parish Plan.

VB felt that Headings in the Community Pride Competition were a guide to work on for the Parish Plan. She reported that we had been short listed for the Community Spirit Award.

There is a meeting with the Community Cheshire Council involving talking about the Community Group and Pickmere Press, which have been listed as one of the village group/activities for the Pride competition, on Monday July 16th. Brenda Wilkinson is invited to attend this. SW to inform!

12. ANY OTHER BUSINESS

- i) CWB reported she had been on course organised by Chalc. "Community Engagement" and found it helpful and informative.
- ii) The pipelines (maps looked at last month) were discussed. Apparently there will be two pipelines gas and water. At the time of receiving those we were told no comments were needed yet. SW reported that no planning has been applied for yet. Likely to be next spring before that happens.
- iii) CWB mentioned calendars for next year. Suggested that it is announced in Pickmere Press that entries for these be handed in at Pickmere Fun Day, and even let people do their entry at the Fun Day. Judge will be needed? Andrea Gough. Originally was to be a Children's Competition for the calendar, but now make it open to all. Need someone to organise this on the Fun Day for those doing it there. PG says we do need to get on and order in good time for selling the calendar. Any subject. A4 size.
- iv) Joan Webb is in a group called "Pickmere Players" which has recently been formed in the village by Andrea Gough. The group need others to join. They are putting on an event in February, consisting of sketches, narratives etc. (small groups). Will need helpers for back stage etc. Joan asked, as part of the group, re. using the Parish Hall for practicing. (?free or subsidised). SW suggested 4 free evenings at the moment, seconded by Council. PG will let Andrea know.
- A couple taking their dog for a walk had reported on tyres being tipped in Spinks Lane . Further reports on rubbish and tyres in Milly Lane and Hall Lane. RF to do letter to Street Cleansing Environment asking can they help.
- vi) RP mentioned the Pickmere Party by the Lake. Help needed for the event.

vii) PG reported on Showground Committee looking into security for Cheshire Show and other activities. They have contracts with people concerned for all events. The caravan event is not on this year. Subject of right turn onto A556 from Flittogate Lane discussed. SW reported that generally no reason why this should be permanent, but just for Show events at Cheshire Showground. Since traffic lights have been in action at "Smoker Pub" this has controlled traffic on A556, creating gaps in the traffic flow. Cheshire Agricultural Society would put in traffic management plans for all the events on showground. Further meetings to take place with police.
