








Salt extraction and potential pillar failure in the Winsford Mine...The proposed HS2 route crosses the Winsford mine. The salt pillars carry the load of the roof and are subject to compression. Pillars will deteriorate with time due to both chemical and physical processes which are difficult to characterise or predict. The voids in the collapsed rock above may or may not reach the surface – with a sudden catastrophic failure.








Budworth Road Budworth Road
